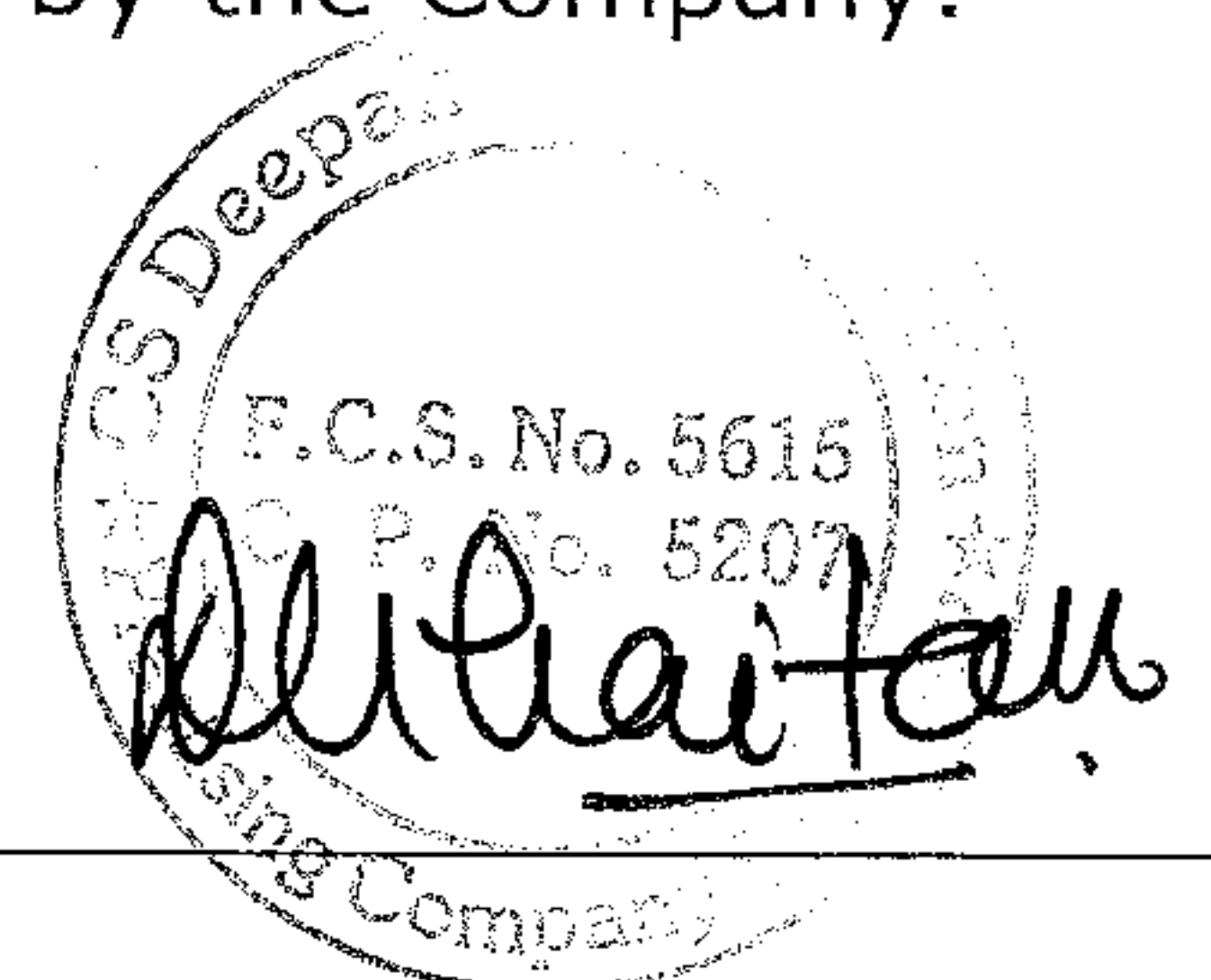

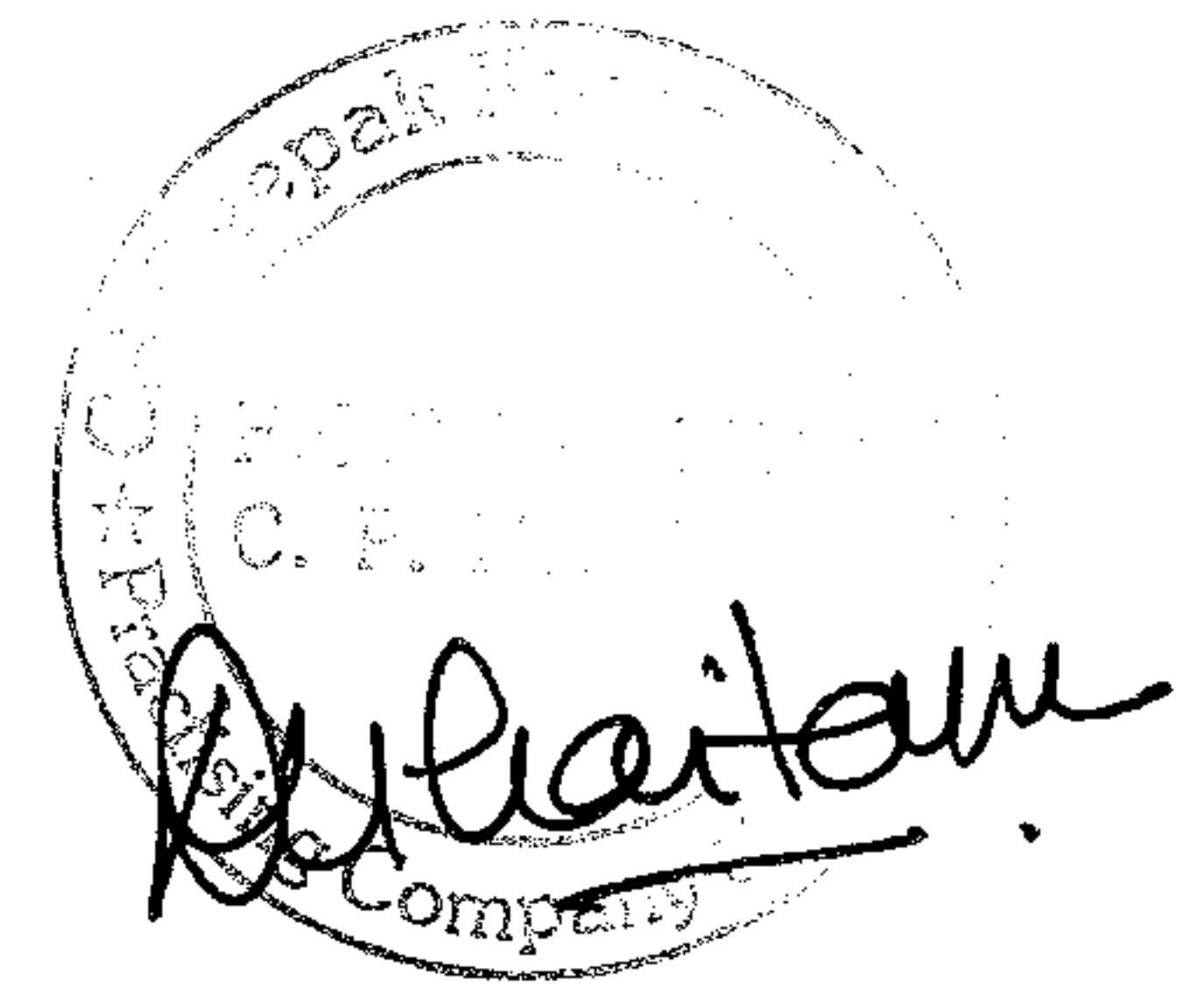
Dear Sir,

Pursuant to the letter dated 27.03.2015 issued by Adhunik Metaliks Limited having CIN:L28110OR2001PLC017271 (hereinafter referred to as 'the Company') appointing me as the Scrutinizer under Section 110 of the Companies Act, 2013 read with Rule 22(5) of The Companies (Management and Administration) Rules, 2014 in respect of Notice of Postal Ballot dated 27.03.2015 (hereinafter referred to as the 'postal ballot'). I have examined the e-voting and other relevant papers and records of e-voting as required for that purpose. In my opinion and to the best of my information and according to the examinations carried out by me and explanations furnished to me by the Company, its officers and agents, I hereby submit my report w.r.t the aforesaid postal ballot (including e-voting) as under:-

1. The company has completed the despatch of the postal ballot forms along with business reply envelope on 01.04.2015 to its members whose name(s) appeared on the Register of Members / List of Beneficial Owners at the close of working hours on 27.03.2015. The postage was paid by the Company. The list of shareholding has been provided by the Registrar & Share Transfer Agent and certified by the Company.



2. The e-voting was unblocked on 04.05.2015 in the presence of two witnesses who are not in employment of the Company i.e. CS Siddhi Dhandharia and Ms.Karishma Chawla.
3. As confirmed by the Company Secretary, no postal ballot forms were received by them upto 2nd May, 2015 as per the aforesaid notice of postal ballot and even till the date of issue of this report.
4. Particulars of all the e-voting received from the Members have been entered in a register separately maintained for the purpose.
5. As confirmed by the Management, they have not received back any undelivered envelope containing postal ballot forms.
6. I am producing before you the register and the related records (including print out of e-voting as available from the login Id from the website being <https://evoting.karvy.com> (Karvy Computershare Private Limited) for verification at your end at the time of submitting this report but they shall remain under my safe custody till you consider, approve and sign the minutes of the meeting.
7. In my opinion, based on the above scrutiny, the resolutions at item nos. 1 to 3 of the above-mentioned notice may be considered to have been passed with requisite majority by means of electronic means (since no postal ballots were received as mentioned in paragraph no. 3 of this report) as understood herein below :-

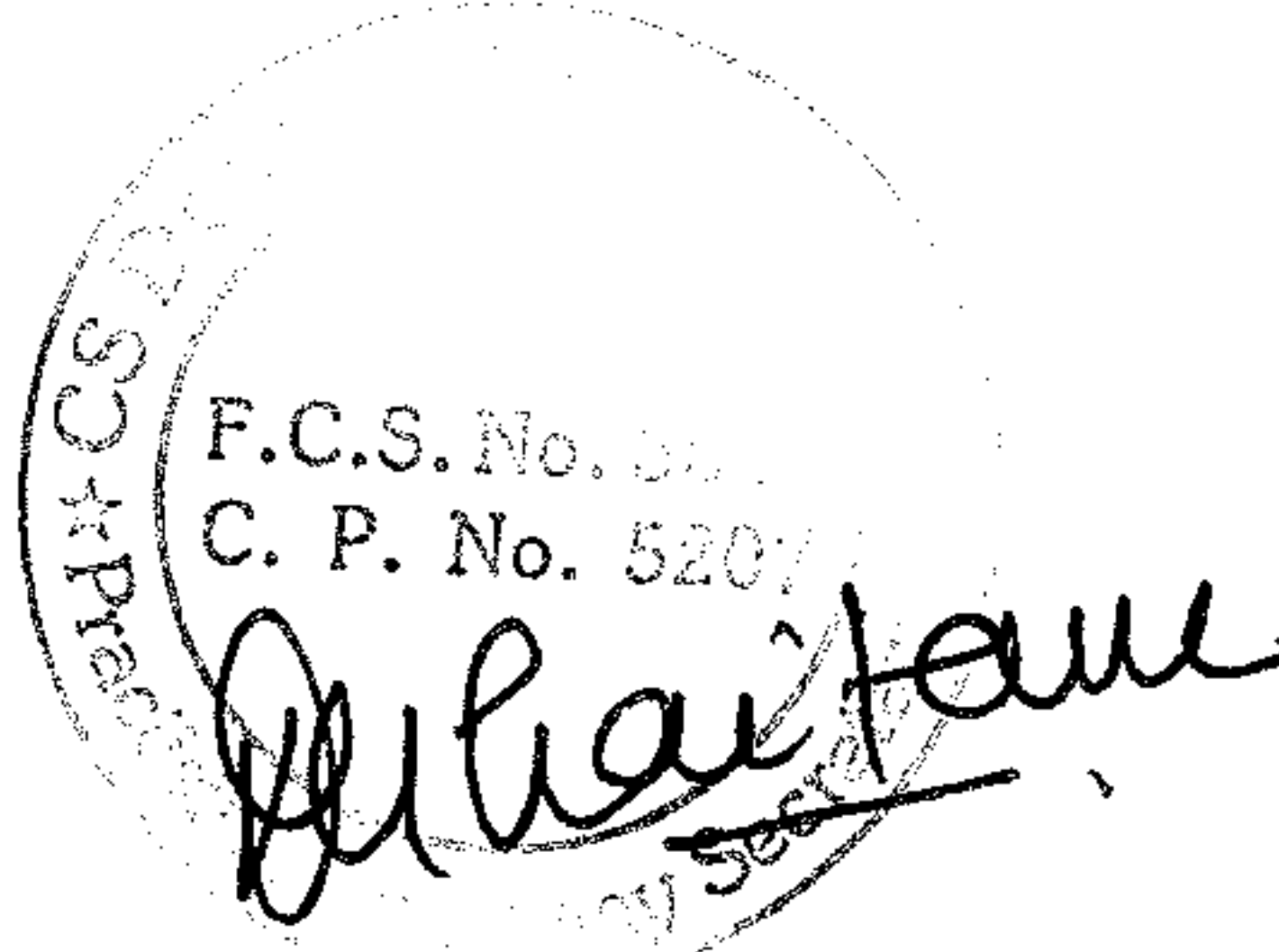

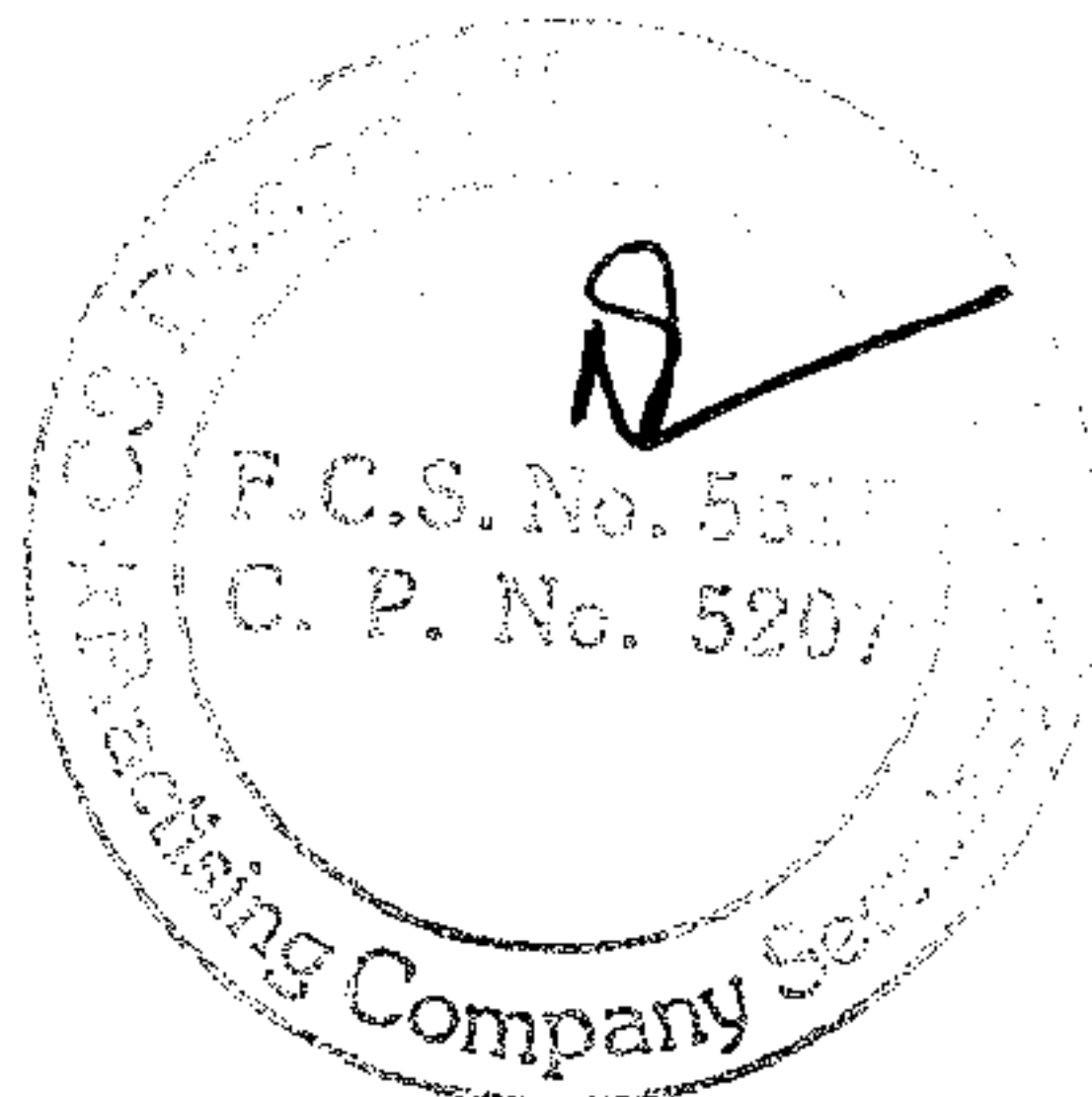
